Continuing Education Requirement

All Montana real estate licensees are required to complete 12 hours of continuing education each licensing year. The current licensing year began November 1, 2023 and ends October 31, 2024.

Continuing Education Policy

Members and non-members must register for all continuing education classes by 4:00 pm on the last business day before the class. Cancellations that take place after 4:00 pm are not eligible for a refund.

Code of Ethics Training

Members are required to complete 2.5 hours of Code of Ethics training during every three-year cycle. The current COE cycle began January 1, 2022 and ends December 31, 2024.

Supervising Broker Courses

These courses fulfill the annual four-hour education requirement for Supervising Brokers. Attendees must hold a current Montana broker's license with a Supervising Broker endorsement.
